Dear Sir,

The above named was appointed on compassionate ground under your letter referred above. It is surprised to note that the widow was appointed in Group-D post as Trainee in minimum of I-S Pay Band excluding GP i.e. Rs. 4440/- and posted under Sr. CGW/ADI (MG). The Railway Board orders under RBE No. 102/2012 circulated vide P.S. No. 43/2012 was available at the time of her appointment, accordingly in case of appointment of widow/wife not fulfilling the requirement of prescribed educational qualification, she will have to be placed in PB-1 (Rs. 5200-20200) GP 1800/- directly without insisting on fulfillment of educational qualification norms.

Union find that in a gross negligence on the part of administration which results in the widow is being paid Rs. 4440/- in I-S pay band without GP since her appointment.

It is, therefore, desired that to revise the appointment orders in terms of existing rules at that time and arrange for payment of difference to employee by regularising pay in PB-1 GP 1800/-

You are further requested to check up with the compassionate appointment cases during such period particularly for such type of mistake and take corrective action, if any.

1. The roster of RDHP staff is introduced under APO(E)ADI's letter dated 15-12-2014. TI/RDHP has not introduced the same. The working place of RDHP staff is away 0.5 KM from station. Thus 10/hrs. dut y roster be introduced effective from 15-12-2014 or 16-12-2014 and the staff be paid allowance for extra hours.

2. Taking into account the working condition of RDHP yard, there should be 2 PPs. TI/RDHP has reduced the same to 01 PP telling this is done as per orders of Sr. DOM/ADI. Kindly look into this, because work is increased including increase in train services.

3. The uniform is not properly supplied to staff. The staff is supplied 02 pair of uniform as is done in the jurisdiction of TI/Bhildi. The uniform as prescribed should be supplied and the uniform not yet supplied should be supplied to staff.

You are requested to please necessary action for re-dressal of these problems early.
