The matter has been examined in this office and it is reiterated that said 'Best Amongst the Failures Scheme' is equally applicable in the category of Stenographers also with the same terms and conditions as applicable to other non-safety category posts as laid down in Board's letter No. $88-\mathrm{E}(\mathrm{SCT}) / / 23 / 1$ dated 28.06 .1995 (RB.No.57/95) wherever the suitability of the candidates is judged through Written Test and/or Viva-voce etc.
3. It is further clarified that there is no relaxation for SC/ST candidates in the Stenography Speed Test over and above the permissible limit of $10 \%$ mistakes of total words dictated as per extant instructions of the Board.
