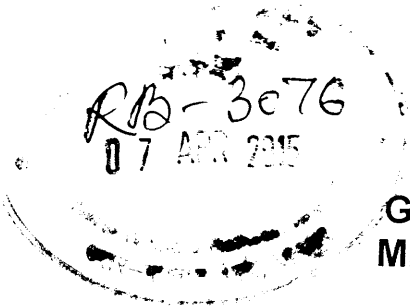

References have been received in Board's office from various Railways expressing doubt regarding applicability of the 'Best Amongst the Failures Scheme' Promotion of SC/ST employees against reserved vacancies in Stenographers grades on Railways.

3. The matter has been examined in this office and it is reiterated that said '**Best Amongst the Failures Scheme**' is equally applicable in the category of Stenographers also with the same terms and conditions as applicable to other non-safety category posts as laid down in Board's letter No. 88-E(SCT)/23/1 dated 28.06.1995(RB.No.57/95) wherever the suitability of the candidates is judged through Written Test and/or Viva-voce etc.

3. It is further clarified that there is no relaxation for SC/ST candidates in the Stenography Speed Test over and above the permissible limit of 10% mistakes of total words dictated as per extant instructions of the Board.

The above may please be brought to the notice of all concerned for its strict compliance.
