> Medical classification of Railway employees and providing of alternate employment - Regarding.

Consequent upon the issue of Board's letter No. 2011/H/5/9 dated 28.10.2011, a doubt has arisen as to whether Railway employees who are declared medically unfit to perform the duties of original post and fit to perform other sedentary jobs in the same medical classification, may be treated as medically unfit for the purpose of providing them alternative appointments and granting of compassionate appointment to wards of such employees in case they seek voluntary retirement. References have also been received from some of the Railways seeking clarifications on this issue.

In the light of the above, the matter has been considered by Board. It has been decided to modify, slightly, Annexure XX of IRMM- 2000 relating to alternative employment on medical grounds. Instructions clarifying this aspect have been issued vide Board's letter No. 2011/H/5/9 dated 29 08 2014 in all the Zonal Pailways in order to make the relevant para of IRMM told consistent with the provisions of IREM Vol. I Revised Edition 1989, First Re-print Edition 2009. This is for information of Personnel Department of Railway who are advised to follow the letter dated 29.08.2014 referred to above. from its date of issue.

Consequent to issuance of Board's letter cited under reference and the Correctio to Para 561 (B) of IRMM, 2000, various suggestions/difficulties in implementation there have been received from time to time. Keeping in view the difficulties being faced by th Zonal Railways, the matter has been examined afresh.

After careful consideration of the matter, it has been decided with the approval competent authority to modify Annexure-XX of IRMM, 2000 relating to Alternal Employment on Medical Grounds by deleting sub-clause "b" of the certificate recommendation for alternate employment on medical grounds.

Accordingly, Advance Correction Slip to Para 561 (B) and Annexure-XX of IRMN 2000 is enclosed herewith.
