The following addendums in para 2.1 in Railway Board letter No. 88/Sec(E)/RC-3/43 Pol. Pt. dated 12/07/2011 have been approved by the Board MS:

(v) An eligible ward/spouse of an RPF/RPSF staff who is partially medically de-categorised and seeks voluntary retirement from service subject to the condition that he/she has at least five(05) years or more service left. Such appointment will be given only in Grade pay Rs. 1800/- irrespective of their qualification.

(vi) An eligible ward/spouse of an RPF/RPSF staff who has been missing may also be considered for compassionate appointment in terms of Board's letter No. E(NG)II/97/RC-1/210 dated 26/07/1998 (RBE No. 164/98)."

This also disposes of the query raised by CSC/SCR vide letter No. MP/268/ACC/7 dated 07/03/2014, 12/03/2014, 04/04/2014 and 05/05/2014.
