Those employees who are not completed two years regular service in the lower grade will be promoted only after the completion of two years service in immediate lower grade.

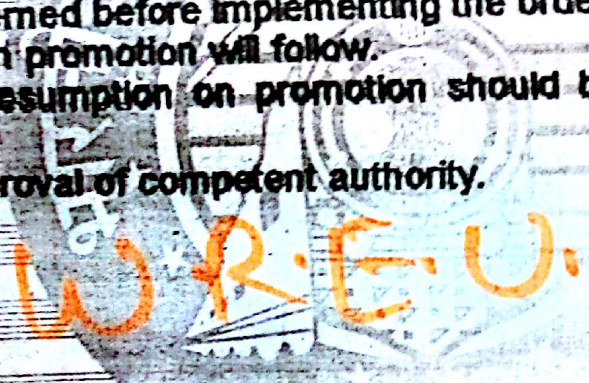
