Sub: Manpower planning norms for three-phase electric locos in Electric Loco Sheds.

Ref: Railway Board's letter No. 2001/Elect.(G)/138/3 dated 16.03.2006

- 1.0 It has been decided by Board (ML, MS & FC) that the manpower planning norm for maintenance of three-phase locos in Electric Loco Sheds would be 2.5 persons per three-phase locomotive in Electric Loco sheds. However, the above yardstick of 2.5 persons does not include laboratory, training school, other running staff like Shunters, Canteen, security/watch & ward activities, Civil Engg./Mech. Engg/ Stores departments.
- 2.0 Activities such as shed cleaning, loco washing, garden maintenance, maintenance of fire extinguisher and sanding activities may be considered for outsourcing in case facilities for in house maintenance does not already exist.
- 3.0 Maintenance of specialized assemblies such as Traction Propulsion System (TPS) including their sub-assemblies could be under AMC, if AMC for maintaining such items is considered inescapable and can't be maintained in house due to their specialized nature.
