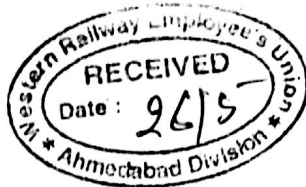
**Sub: - Lower Division Grade Limited Departmental Competitive Examination 2015-

It has come to notice that some of the zonal Railways are forwarding the applications of their Group 'C' staff working in GP of Rs. 1800/- directly to Staff Selection Commission for Lower Division Grade Limited Departmental Competitive Examination - 2015.

2. It is pertinent to mention here that in the notice of Lower Division Grade Limited Departmental Competitive Examination-2015 (notified by SSC) is to be conducted for recruitment to vacancies in lower Division Grade of Railway Board Clerical Service (RBCS) and only Group 'C' employees with Grade Pay of Rs.1800/- of Railway Board are eligible to appear in the said examination. No Group 'C' employee of Zonal Railway/Production Unit is eligible for examination.

3. Applications of Group 'C' employees with Grade Pay of Rs. 1800/- working in your Railway/Unit should not, therefore, be forwarded to Staff Selection Commission for the Lower Division Grade Limited Departmental Competitive Examination,2015 and in future also. This may also be brought to the notice of all the concerned on your Railway/Unit and it may also be ensured that such lapse does not recur in future.

1. There are various policies framed from time to time and revised subsequently on house allotment/retention applicable to various situations such as transfer, deputation, retirement deputation to Railway PSUs/Non Railway PSUs posting as faculties in Training Institutes/Chairmen RRB and to projects etc. Besides the normal relaxations granted for quarter retention in cases of transfer, retirement death etc., the Board in exercise of its power to relax in the existing policies on house allotment/retention, sanctions from time to time, relaxations for various tenures in different categories of cases such as chairman RRB, New Zones/divisions, USBRL project, Training Institutions etc.
2. Of late this office has been receiving queries from various sources relating to subject in various forms as listed in the table given as Annexure "A". The matters, in a consolidated, have been examined by the full Board and the decisions taken in respect of each of such queries proposals etc. are noted against each of the queries in the said table.
