“(xix). The Pension Account holding bank will be responsible for obtaining periodical certificates such as Life Certificate, Re-employed Certificate etc. (as prescribed in CPAO’s Scheme for “Payment of Pensions to Central Government Civil Pensioners through Authorised Banks”) and intimated electronically to CPAO on due dates. (Life certificate should be obtained *by* 1<sup>st</sup> November each year and intimation uploaded on CPAO’s website). Drawing of pensions/family pensions will be subject to the receipt of Life Certificate by CPAO”.
