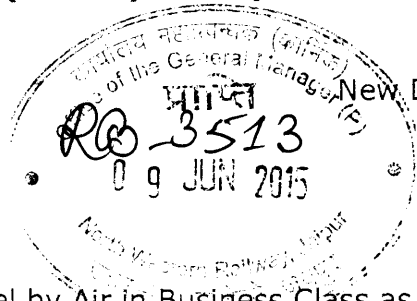

Sub: Clarification on travel by Air in Business Class as stipulated in Economy Measures issued by Ministry of Finance.

A clarification has been sought with reference to para 2.4 (II) of MOF's O.M. on Economy measures dated 29<sup>th</sup> October, 2014 circulated vide board's letter no.2013-B-260 dated 19.11.2014 which reads as follows:

*"While officers are entitled to various classes of air travel depending on seniority, utmost economy would need to be observed while exercising the choice keeping the limitations of budget in mind. However, there would be no bookings in First Class."*

2. It has been decided by the Railway board that officers of the level of SAG & above may be permitted to travel by Business Class during their domestic travel as per their entitlement subject to availability of Budget provision.

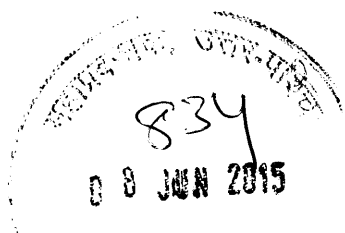
