Please connect N.W.Railway's letter ibid on the above subject. In this context, it is advised that in terms of Annexure 'E' of Board's cadre restructuring orders no. PC-III/2013/CRC/4 dated 08-10-2013, 65% of posts of Pharmacists cadre are placed in GP Rs. 2800 and Rs. 4200 (NFG) combined and balance 35% of posts are placed in GP Rs. 4600. There are no instructions issued by Board about merger of GP Rs. 2800 with GP Rs. 4200 (NFG) in the Pharmacists cadre. No separate %age distribution of posts has been shown between GP Rs. 2800 & GP Rs. 4200 (NFG) in view of the earlier instructions issued by Board vide letter no. PC-VI/2009/I/RSRP/10 dated 30-03-2010 and PC-VI/2010/IR-N/2 dated 19-11-2010.

It is noticed that N.W.Railway has not followed Board's instructions dated 30-03-2010, 19-11-2010 & 08-10-2013 mutatis-mutandis and placed all the Pharmacists in GP Rs. 4200 by taking wrong interpretation of Board's cadre restructuring orders dated 08-10-2013 and without seeking any clarification from Board on this issue.

It is requested that N.W.Railway may take corrective steps expeditiously. Further, in view of the above facts, Board has taken a serious view of the matter and desires that responsibility for these lapses should be fixed for not taking action as per Board's letters dated 30-03-2010, 19-11-2010 and 08-10-2013 and the Board be advised early.
