The undersigned is directed to say that instructions were issued vide this Department's OM of even No. dated 14.11.2007 that subject to exigencies of work special casual leave for not more than 10 days in a calendar year may be granted to differently abled Central Government servants with disabilities as defined in the Persons with disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 for participating in the Development related programmes organized at National and State level conferences/workshops/seminars/trainings agencies to be specified by Ministry of Social Justice and Empowerment.

- All Ministries/Departments are now informed that it has been decided in consultation with Ministry of Social Justice and Empowerment that the special casual leave to the differently abled Central Government employees with disabilities as per the above O.M dated 14.11.2007 may be allowed for conferences/workshops/seminars/trainings Disability and Disability related programmes organized by the following: participation
  - Central Government and State/UT Governments;
  - Central and State/UT Government Institutions/Agencies; (i) (ii)
  - International agencies like UN, World Bank etc; (iii)
  - Universities & Educational Institutions set up by Central/State Government, recognized as predominant centres for education (yi)on rehabilitation of persons with disabilities and
  - institutes for persons with disabilities, under Chapter X (Sections 50 to 55) and Chapter XI (Section 56) of the Recognised Persons with Disabilities (Equal Opportunities, Protection of  $(\mathbf{v})$ Rights and Full Participation) Act, 1995
  - There shall be no change in the other conditions for grant of special conferences/workshops/seminars/training for Disability and Development related programmes by the differently abled Central Government employees.
