During the Presidents Secretaries Meeting (PSM) of Railway Sports Promotion Board, held at Rail Bhawan on 18.05.2015, it was decided to stop recruitment of sportspersons against sports quota through Talent Scouting, on the basis of medal winning position in All India Inter University Championships, as per Board's policy letters mentioned above. The proposal has accordingly been considered and approved by Railway Board.

2. It is, accordingly, advised that for all future recruitment (from the year 2015-16 onwards) in Grade Pay Rs. 1900/2000 in scale Rs. 5,200-20,200 (PB-I) against sports quota on the basis of medal winning performance (at least 3rd position) in All India Inter University Championships may only be considered for recruitment against Open Advertisement Quota. However, in such cases where trials have already been conducted for recruitment through Talent Scouting, before the date of issue of this letter, the same may be finalized as per policy.
