The employees who are working as comml clerk / TC / TNC / on adhoc basis may also apply in reference to this selection. They are not automatically eligible to appear in the selection. They are likely to be reverted to their substantive posts if they do not qualify in selection.

**DS-WREU**

The eligible staff should submit applications on the Performa addressed to DRM (E) ADI through their supervisory staff concerned who will submit the same in bunch along with the list of the staffing sealed cover addressed to APO-(T) ADI. So as to reach this office latest by 18.09.2015 without fail. Applications received thereafter will not be considered.

The selection will consists on the basis of written test followed by Record of Service examination. Written test will consists of one paper of 3 hours duration divided into two parts- Part A to test the working knowledge of the railway servants to the English language and Part 'B' general standard of intelligence and proficiency through questions in arithmetic, General knowledge mainly pertaining to railway matters and matters immediately pertaining to the work he has been acquainted with during his Railway service.

The selection will be made as per extant rules. There will be a selection for the post TE. It is advised that absorption of the employees in these categories will be decided by the competent authority on finalization of absorption in TE category only.

**DS-WREU**

The selected candidate will have to undergo prescribed training. The standard of training imparted will be same as for direct recruits for the same Group 'C' categories and in case of failures in the first attempt; such employees may be given a second chance to qualify. Selected candidate, have to pass the requisite medical category prescribed for the posts i. e. B/2 for TC if necessary.

The concerned subordinates should ensure that the notification is got noted to all the eligible staff and those who are on leave or under sick list by sending intimation to their address. This should be given wide publicity and copy of this notification should be placed on 'Notice Board'.
