1. Option for fixation of pay under Rule 1313(1) (a)(i) of the IREC Vol-II to get next pay fixed in higher post/grade pay either from the date of promotion/ up gradation or from the date of his next increment i.e. 1st July of the year shall be admissible to the employees and may submit their option within one month from the date of issue of the order.
2. Before giving effect of these order it may be ensured at unit level that no DAR/B&C/ Vigi./ case pending against the employees or the employees undergoing penalty of stoppage of increment etc.
3. Consequent upon grant of financial up gradation under the MACP Scheme there shall be no change in the designation, classification, or status of the employees and it shall be purely personal to the employee, moreover it shall have no relevance to one seniority position. As such no additional financial up gradation/ stepping of pay etc. shall be admissible to the senior employees on the ground that the juniors are placed in higher grade pay.
