NOTE: - Shri SALIM Y CHISTY CHRI-MSH is undergoing penalty up to 30.06.16, hence will be promoted after completion of penalty.

Unit In charge must ensure that before reliving/resumption of the staff to carry out the promotion there should not be any major DAR/B&C case pending, or undergoing penalty of stoppage of promotion/increment and reduction on Date of resumption respectively, in such cases the employee should not be allowed to resume the duty on promotion and a report should be sent to Divisional office immediately.

Unit in charge may ensure that, the employees who have been promoted and posted at other stations are to be relieved on promotion within 15 days or their unwillingness to be sent to this office, after 15 days any employees are not to be detained without approval of branch officer. If employees not resuming duty on promotion in new station within one month, they should deemed debarred for promotion from the date of promotion orders.

They are eligible for any transfer privileges, like joining time, composite transfer grant, pass etc. except Sr.No.2.

As per extant rules, they should give the option for fixation of their pay which should reach to this office within one month of issue of this order.
