NOTE: 1) Fixation on promotion will be done by ADEN office. The pay of the staff promoted against the vacancies from the date of restructuring orders will be fixed on proforma basis as per Rule 13 of RSRP Rules with the benefit of one increment @ 3% of the basic with the usual option for pay fixation as per extant rules. **The actual payments will be made from the date of taking over charge of the higher grade post.**

2) The employees have been promoted vide under ref. letter and have not resumed till date. They are not entitled for benefit of proforma fixation, their debaration letter may be issued by concerned ADEN Office under advise to this office.

Those employees who are not completed two years regular service in the lower grade will be promoted only after the completion of two years service in immediate lower grade.


