- **Unit In charge must ensure that before relieving/resumption of the staff carry out the promotion, there should not be undergoing penalty of stoppage of promotion/increment and reduction on date of promotion, in such cases the employee should not be allowed to resume the duty on promotion and report should be sent to Divisional office immediately.**
- If above employee have occupied of Railway quarter should vacant the same as per extant rule at once on transfer, failing which panel rent will be recovered for unauthorized retention of quarter without prior approval from this office.
